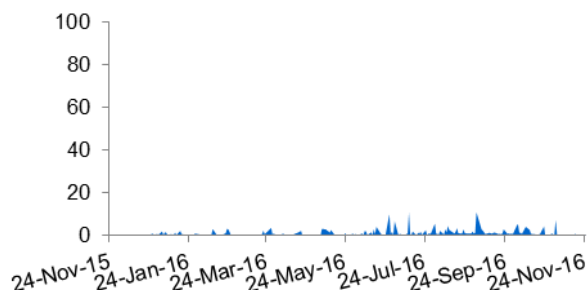


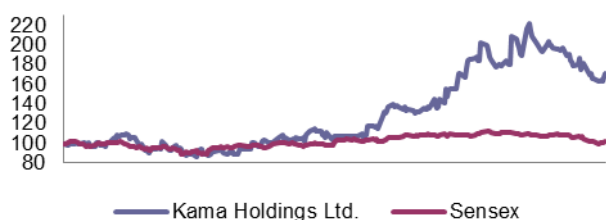

BSE Volumes Trend - Average = 1.08 Thousand

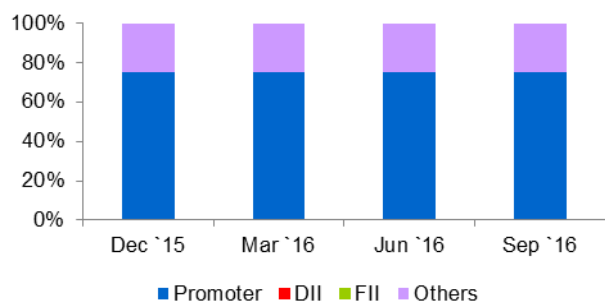


Relative Returns
