The company's management personnel include Mr. P. Viswanathan the Chairman. The company has three subsidiaries holding 100% share in Inditrade Business Consultants Limited, 91.5% in Inditrade Derivatives and Commodities Limited, and 57% in JRG Fincorp Ltd. 
