

Quarter results overview

Result performance review

- Gokak Textile's net sales increased by 3.4% on a year on year (YoY) basis. Its expenses, however, increased at a higher rate of 7.1% during the same period.
- The company reported an operating loss of Rs 3.8 m during the quarter as compared to profit of Rs 26 m during the same quarter of the previous year.
- Depreciation charges declined by 0.8% YoY, while interest expenses increased by 9.3% YoY.
- The company's losses increased to Rs 79.9 m as compared to a loss of Rs 45.7 m during the same quarter of the previous year.






Since the company reported trailing twelve months EPS of negative Rs 27.5, its P/E ratio is not meaningful.




Quarterly financial trend charts
