





### Half-Yearly results overview

### Result performance review

- The company's net sales declined to Rs 4.2 m in 1HFY15 as compared to Rs 12.7 m in 2HFY14.
- The company's expenses decreased to Rs 5 m in September 2014 as compared to Rs 19.4 m in March 2014. Operating loss of the company stood at Rs 0.8 m for the half as compared to a loss of Rs 6.8 m in 2HFY14.
- Depreciation declined to Rs 0.6 m while interest charges remained nil for the half ended September 2014.
- Profit after tax was up to Rs 3.5 m for the half year. It may be noted that the company did not pay any tax during the period.




### **Current valuation**
