

VCU Data Management Ltd reported a 22.2% YoY decline in total income to ₹28.7 million in FY16 from ₹36.8 million in FY15.

EBITDA margins declined substantially in FY16, reaching 19.9% from 33.5% in FY'15.

The company reported a net profit of ₹2.3 million or ₹0.15 per share for FY'16 compared to a net profit of ₹9.15 million or ₹0.59 per share in the prior fiscal year.




