# Quarterly result review – June 2016

Quantum Build-Tech Limited reported a 92.2% YoY decline in total income to ₹3.21 million in Q1'FY17 from ₹41.15 million in Q1'FY16. On a sequential basis, total income decreased 1.5% from ₹3.26 million in Q4'FY16.

EBITDA came in at  $\gtrless$  1.68 million compared to  $\gtrless$  1.18 million in the prior year quarter and  $\gtrless$  3.23 million in the preceding quarter.

The company reported a net profit of  $\gtrless$  0.77 million or  $\gtrless$ 0.06 per share during the quarter compared to a loss of  $\gtrless$  0.62 million or  $\gtrless$  (4.28) per share in the prior year quarter.


