- ✓ On a q-o-q basis, the total income decreased from ₹10.6mn to ₹2.9mn for the quarter ended 31 December 2015.
- ✓ EBITDA for the Q3'16 were at ₹(1.6)mn up from ₹(2.3)mn in Q3'15, EBITDA margins were negative.
- ✓ Profit for the third quarter of FY16, was at ₹(4.0) million.
