# Quarterly result review - June 2017

Quantum Build-Tech Limited reported a 156.70% YoY increase in total income to ₹8.24 million in Q1'FY18 from ₹3.21 million in Q1'FY17. On a sequential basis, total income increased 128.25% from ₹3.61 million in Q4'FY17.

EBITDA came in at ₹6.81 million compared to ₹1.68 million in the prior year quarter and ₹8.26 million in the preceding quarter.

The company reported a net profit of ₹6.74 million or ₹0.53 per share during the quarter compared to a net profit of ₹0.77 million or ₹0.06 per share in the prior year quarter.


