

UCC Batch Upload file format

The Input file format is given below in detail and the following information is uploaded into the system during the processing of this file:

The file format consists of pipe separated two rows. The first row consists of general information applicable to all the client types. However, the second row will be applicable only if the user needs to enter the Director details, if any. Hence, if the client code is of client type INDIVIDUAL and INSTITUTION then the user need not submit the second row.

First row consists of General *Information* applicable for all client types.
