## Sub:In the matter of Union of India, Ministry Of Corporate Affairs VersusInfrastructure Leasing And Financial Services Limited [IL&FS] &<br/>Others - Circulation of order dated 03/12/2018 in CP No.3638 of 2018passed by Hon'ble NCLT, Mumbai Bench - reg.

Sir,

The Union of India, Ministry of Corporate Affairs had filed a petition under Section 241-242 of the Companies Act, 2013 against Infrastructure Leasing And Financial Services Limited [IL&FS] & Others vide CP No.3638 of 2018 before the Hon'ble National Company Law Tribunal, Mumbai Bench. The Hon'ble Tribunal was pleased to suspend the Board of Directors of the Respondent No.1 Company and the directors nominated by the Central Government were appointed.

Amongst others, Shri Hari Sankaran (Respondent No.2), Shri Arun K Saha (Respondent No.3) and Shri Ravi Ramaswami Parthasarathy (Respondent No.9) are the Respondents in the original petition. Further, Shri Vibhav Kapoor, Shri K. Ramchand, Shri R.C. Bawa, Shri Pradeep Puri, Shri S. Rengarajan and Shri Mukund Sapre have been added as Respondent No.313 to 318.

During the course of proceedings, Union of India had filed an application on 03/12/2018 and the Hon'ble Tribunal was pleased to pass an order directing, *inter-alia*,

"Further direction is being issued against the above mentioned Respondent Nos. 2, 3, 9 and 313 to 318 restraining them from mortgaging or creating charge or lien or creating third party interest or in any way alienating, the movable or immovable properties owned by them, including jointly held properties.

The above mentioned Respondents are further restrained from dealing with the securities in any company till the next date of hearing."
