Subramanian, Practicing Company Secretary, appointed as the Scrutinizer for the meeting of equity shareholders by the Hon'ble High Court at Calcutta for the purpose of the postal/ e-voting taken on the below mentioned resolution at the meeting of the Equity Shareholders of WPIL Limited held on the 16th day of January, 2017 pursuant to the Order dated the 28th November 2016 of the Hon'ble High Court at Calcutta (for approval of the Scheme without modification) do hereby submit my report as under:-

- 1. The voting period began on 16th day of December, 2016 at 10:00 A.M. (IST) and ended on 15th day of January, 2017 at 5:00 P.M. (IST).
- 2. The shareholders holding shares as on the "cut off" day i.e. 7th December, 2016 were entitled to vote on the proposed resolution as mentioned in the notice dated 8th day of December, 2016 of the Court convened Meeting of the Company and also stated hereinbelow.
- After the time fixed for closing the poll by the Chairperson, one ballot box kept for polling were locked in my presence with the identification mark placed by me and the authorizations / proxies lodged with WPIL Limited.

The votes for e-voting were unblocked on Monday, the 16th day of January, 2017. Thereafter the details containing, inter-alia list of equity shareholders, who voted "For" and "Against", we've downloaded from the e-voting website of National Securities Depository Limited.

- 5. The locked ballot box was subsequently opened in my presence and in the presence of two witnesses and poll papers were diligently scrutinized. The poll papers were reconciled with the records maintained by WPIL Limited.
- 6. None of the poll paper was found invalid.
