SpiceJet to Fly **Light with Sale** & Leaseback **Fleet Additions**

New Delhi: No-frills Indian carrier Spice-Jet will use the 'sale and leaseback' route to induct about a sixth of the 275 aircraft it has ordered, sticking to its goal of staying asset-light until the fleet expansion scheduled over the next three years is complete.

"Our strategy is to keep the airline assetlight in the period until 2020. As part of that, we will induct about 48 aircraft on sale and leaseback mode. We expect to fetch good deals on the sale and leaseback, as the market is conducive for it," Spicejet Chief Financial Officer Kiran Koteshwar told ET. The model to be followed for further or-




