Brief Note on Business and Financial Aspect of Scheme of Amalgamation and Arrangement under Sections 391 to 394 read with Sections 100 to 103 of the Companies Act, 1956 Scheme of Amalgamation and Arrangement between Welspun Enterprises Limited ('WEL'), Welspun Infratech Limited ('WITL'), Welspun Plastics Private Limited ('WPPL'), Welspun Infra Projects Private Limited ('WIPPL') (hereafter referred as 'Transferor Companies') and Welspun Projects Limited ('WPL' or 'Transferee Company') and their respective Shareholders and Creditors ('Scheme')

- 1. This Scheme presented under Sections 391 to 394 read with sections 100 to 103 and other applicable provisions of the Companies Act, 1956, provides for the Merger of WEL, WITL, WPPL, WIPPL with WPL with Appointed Date as April 01, 2014
- 2. Rationale of the Scheme of Amalgamation and Arrangement are Interalia summerised as under:
  - a) All the Companies are part of the Welspun Group ("the Group").
     The Scheme of Amalgamation and Arrangement between Transferor Companies and Transferee Company would inter alia have the following synergies for the group:
    - Consolidation and simplification of the Group Structure;
    - Elimination of multiple companies in the Group;
    - Reducing operating and compliance cost;
    - Achieving operational and management efficiency; and
    - Synergies arising out of consolidation of business, such as, enhancement of net worth of the combined business to capitalise on future growth potential, optimal utilisation of resources.
- 3. Upon the Scheme becoming effective, the consideration would be discharge as under:
  - To the Shareholders of WEL (including the GDR holders of WEL)

"Every equity shareholder of WEL holding 1 (one) equity shares in WEL of Rs. 10 each fully paid up as of the Record Date shall be entitled to be 12 (Twelve) shares of face value Rs. 10 each, issued at par, credited as fully paid up, of WPL"

- Upon amalgamation of WEL with WPL, WITL would become a wholly owned subsidiary of WPL and accordingly no shares shall be issued and allotted by WPL to the shareholders holding shares in WITL.
- Upon amalgamation of WEL with WPL, WPPL shall become a step down subsidiary of WPL and accordingly no shares shall be issued and allotted by WPL to shareholders holding shares in WPPL.
