

**Genus Power Infrastructures Limited****9M FY16 Sales at Rs.657.80 crore****9M FY16 Net Profit at Rs.64.68 crore, Up by 125% YoY**

Genus Power Infrastructures Limited ("the Company" or "Genus Power"), one of the largest manufacturers/providers of 'Smart Metering & Metering Solutions', and also undertaking 'Engineering, Construction and Contracts', today announced its financial results for the quarter and nine-months ended December 31, 2015.

**Financial Results Overview - Nine Months ended December 31, 2015 v/s December 31, 2014:**

The Company has registered strong financial performance for the first Nine-months of FY2015-16.

- **Sales** grew by 5% to **Rs.657.80 crore** from Rs.625.04 crore reported in the corresponding period of the previous year.
- **Profit before interest, tax, depreciation and amortization (EBITDA)** increased by 24% to **Rs.101.16 crore** from Rs.81.44 crore reported in the corresponding period of the previous year.
- **Profit After Tax (PAT)** rose by 125% to **Rs.64.68 crore** from Rs.28.70 crore reported in the corresponding period of the previous year.
- **Earnings Per Share (EPS) (Basic)** for the nine-months is **Rs.2.52** (Face Value of Share: Re.1).

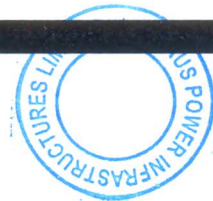
**Financial Results Overview - Quarter ended December 31, 2015 v/s December 31, 2014:**

The Company has reported a solid financial performance in the third quarter of FY2015-16.

- **Sales** decreased by 4% to **Rs.206.39 crore** from Rs.214.78 crore reported in the corresponding quarter of the previous year.
- **Profit before interest, tax, depreciation and amortization (EBITDA)** increased by 8% to **Rs.28.67 crore** from Rs.26.52 crore reported in the corresponding quarter of the previous year.
- **Profit After Tax (PAT)** increased by 28% to **Rs.18.75 crore** from Rs.14.64 crore reported in the corresponding quarter of the previous year.
- **Earnings Per Share (EPS) (Basic)** for the quarter is **Re. 0.73** (Face Value of Share: Re.1)
