a) Completion of term of two Independent Directors:

Dr. S. K. Gupta and Mr. Sudipto Sarkar, Independent Directors have ceased to be on the Board upon completion of their term as Independent Directors, on 28th July, 2015.

b) Appointment of Mr. Malay Mukherjee as an Independent Director:

Mr. Malay Mukherjee holds a Master's degree in mining from the USSR State Commission in Moscow and a Bachelor of Science degree from the Indian Institute of Technology in Kharagpur, India and has over 40 years of experience in a range of technical, commercial and managerial roles in the mining and steel industry. Stainless Steel, Pipes and Tubes and Technology. He has also served as the COO for Mittal Steel Company and as President and Chief Operating Officer of Ispat International (now part of Arcelor Mittal), Executive Director for Mexico, Managing Director (Mexico), Managing Director Ispat Kazakhstan, CEO of Ispat Europe (Luxembourg), the COO of Ispat International (London) and as Executive Director of Works at the Bhilai Steel Plant at Steel Authority of India Limited.

Mr. Mukherjee is a recipient of the MECON Award from the Indian Institute of Metals. Mr. Malay Mukherjee is also a Member of Academy of Natural Sciences Kazakhstan and Life Member in the Indian Institute of Metals.

He was awarded letter of appreciation from the President of Kazakhstan for work rendered in Kazakhstan from 1995 to 1999.
