REF: Notice of 41st Annual General Meeting held on 29th April, 2015

We M/s. dvmgopal & associates, Company Secretaries, represented by Mr. D.V.M. Gopal, were appointed as Scrutinizers by vide resolution passed by the Board at its Meeting held on 29th April, 2015;

- a) To scrutinize the Remote E-voting process for the items to be transacted at the 41st Annual General Meeting to be held on 28.07.2015 along with Ballots received, who could not access the remote E-voting;
- b) To scrutinize the Physical Ballot (Poll) voting process at the 41st Annual General Meeting at 11.00 am on 28.07.2015 for the shareholders who have not opted to vote through the Remote e-voting process.

The Company has also allowed physical voting through Poll System for those shareholders, who are present at the meeting and have not opted to vote through the remote e-voting process at the Company's Annual General Meeting held at 11.00 A.M. on July 28, 2015.

We hereby submit our report as under:

- The remote e-voting period remained open from 09.00 A.M. on 23<sup>rd</sup> July 2015 to 05.00 P.M. on 27<sup>th</sup> July, 2015. Upon conclusion of the e-voting period, the E-voting votes were unblocked on 28th July 2015 at around 01.00 P.M. in the presence of two witnesses' Ms. Shriya Sood and Ms. Annie Jodhani, who are not in employment of the Company.
- 2. At the AGM, Physical Ballots duly filled were deposited in ballot box kept open for voting, upon completion, the same were un-locked in my presence.
- The Shareholders as on July 21 2015, the cut-off date are entitled to vote on the proposed resolutions contained in the notice of the Annual General Meeting.
- 4. On completion of voting at the Meeting, the RTA & Service Provider, M/s. Karvy Computershare Private Limited provided us with the List of Members who had cast their votes, with their holding details and details of vote on each of the Resolutions.
