Sub: Clarification / information on news item appearing in "CNBC TV 18"

This is with reference to your letters dated 23<sup>rd</sup> December, 2016 seeking clarification on the news item appeared in CNBC TV18 dated December 23, 2016 captioned "The media reports that: "Emkay says on Vizag 483 observation: 1.Proper control not being exercised over computer system 2. Facility equipments not maintained to ensure purity quality strength 3. Documentation and records not maintained or inaccurate falsified."

We hereby submit our response as follows:

Clarification/confirmation on the news item in detail including the following whether you/company are aware of any information that has not been announced to the Exchanges which could explain the aforesaid movement in the trading? If so, you are advised to provide the said information and the reasons for not disclosing the same to the Exchange earlier as required under regulation 30 of the SEBI (LODR) Regulations, 2015.

Further with reference to email received from NSE, we clarify as follows:

We have been issued a form 483 with 5 observations and these shall be responded within the time permitted."
