Dr Sancheti currently holds the prestigious positions of general secretary of Asia Pacific Knee Society, vice president of Indian Association of Sports Medicine and founder member of Indian Society of Hip and Knee Surgery.

Maha BJP women's wing hold protest against Rahul Gandhi in Mumbai



Mumbai, August 10 (UNI) : The women's wing of Maharashtra unit of BJP staged an agitation here on Thursday to protest against senior Congress leader Rahul Gandhi for blowing a flying kiss in parliament during debate on no-confidence motion.

The agitators, led by party's

women's wing state president Chitra Wagh, staged protest under the statue of Mahatma Gandhi amidst sloganeering against the Congress MP.

The Mahila Morcha activists said that legal action should be taken against Rahul Gandhi. They demanded that Gandhi should apologise to women of the country.

CEO Kidnap : FIR registered against son of Sena MLA and others

Mumbai Aug 10 (UNI) : Police on Thursday registered an FIR against Raj Surve, son of Shiv Sena MLA Prakash Surve (Shinde Faction), and 15 others for allegedly kidnapping a CEO for ransom in Goregaon area of city suburb. A Complaint was made by Rajkumar Jagdish Singh, CEO of Global Music Junction Private Limited, which provides digital collateral loans. Businessman, Manoj Mishra from Patna, Bihar, borrowed Rs. 8 crore from Singh's company in 2021 for a YouTube channel. The agreement stated that Mishra would repay 11 crore to Singh in 5 years.

According to the complainant, Mishra used the loan for purposes other than the YouTube channel, causing Singh's company to suffer less profit. Singh's company asked Mishra to use the loan for the intended purpose, but Mishra asked for more money, which Singh declined. In 2022, Mishra began pressuring Singh to cancel the agreement. In 2023, they agreed to a settlement, and Singh transferred one crore to Mishra's company between June 2023 and July 2023.

According to Rajkumar Singh's statement, he was forcibly picked up from his office yesterday and was pressured at gunpoint to settle a business loan given to Manoj Mishra of Patna. "Rajkumar was taken to MLA Prakash Surve's office in Dahisar, where MLA's son Raj Surve and his men threatened him at gunpoint to settle the matter and not speak about the same to anyone," the FIR said.

Kolhapur: Four killed, six injured in accident

Kolhapur, Satara, Aug 10 (UNI) : Four people, including two women, were killed on the spot while six others seriously injured in an accident that occurred at Dhondewadi village near Suryachiwadi in Khatav tehsil of Satara district on Thursday morning. According to Khatav police, eight people from Siddheshwar-Kuroli were on their way to take 'darshan' of Shree Sant Balumama in Lokarewadi in the Omani Maruti van of one Pandurang Deshmukh. Near Dhondewadi, a speedy car driver lost control of the wheel, and a van hit a tree at the roadside. In this incident, four people, including two women, were killed on the spot, while six others were seriously injured and were admitted to Waduj.
