August 14 is the last date to submit queries to the DMG, while September 6 is the deadline for submitting the hard copy of the technical bid. As per the inventory of the DMG, the state has around 733 million tonnes of dumps at 313 locations at various places. Besides, there are possibilities of dumps at some locations which are not inventoried. Further, there are stacks of ore both, inventoried and non-inventoried, which are to be auctioned in the future.

The DMG needs to ascertain the quantity of the dump before auctioning so that the bidder is aware

The RFP document says that the pilot flying the drone should have a valid remote pilot certificate from an approved Directorate General of Civil Aviation (DGCA) remote pilot training organisation. Further, the bidder should have executed at least two Drone LiDAR surveys during the last five years. The drone used for the survey must have DGCA licensing certificate.
