Sub: Compliance with Clause 36 of the Listing Agreement

We refer to our letter dated 24th February, 2015, letter no. APL/SEC/08/260, wherein we had stated that the Company was exploring the possibility of setting up paint manufacturing facilities in the Southern States of the country being states of Andhra Pradesh and Karnataka and that the Company was in advanced stage of negotiations with the respective state governments.

Further, the Company had vide its letter dated 10th March, 2015 informed that the Company had entered into and signed a Memorandum of Understanding (MoU) with the Government of Andhra Pradesh to set up a manufacturing facility for paints and intermediates at Pudi Village, Rambilli Mandal, Vishakhapatnam District, Andhra Pradesh and an amount of approximately Rs. 1750 crores would be invested by the Company in phases over a period of 12 years from the date of commencement of construction, including the cost of land admeasuring approximately 110 acres, subject to due diligence and obtaining necessary regulatory and other approvals.
