With reference to your above letter(s), we would like to inform that CONCOR is mainly engaged in the business of handling/transportation of containerized cargo and rail is the main mode of transporting containers for its customers.

In respect of above subject matter, it is clarified that CONCOR has not inked any specific pact for rail connectivity with M/s Allcargo Logistics for CONCOR's facility at Tehi, Indore. However, in the normal course of its business, CONCOR moves the containers for its customers through rail, including M/s All Cargo Logistics. The tariff/charges for the rail transportation are notified by CONCOR from time to time. We would like to reiterate that CONCOR is committed to comply with the SEBI (Listing Obligations & Disclosure Requirements) Regulations for disclosures. The movement of containers by Rail for a specific customer in the normal course of its business is not a unpublished price sensitive information and it does not have any material impact on the operation/performance of the Company. Therefore, the above is not covered by the disclosure requirements under the SEBI (LODR) Regulations.

We hope the above clarifies the matter.
