Pursuant to Regulation 30 of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015 ("SEBI LODR") and in accordance with the requirements of Clause 16(b) of Para A of Part A of Schedule III of LODR, we hereby inform you that:

- 1. M/s Laburnum Chemicals Private Limited ("Laburnum") has filed an application against Kirloskar Electric Company Limited (the Company) to initiate Corporate Insolvency Resolution Process under Section 7 of the Insolvency and Bankruptcy Code, 2016 read with Rule 4 of the Insolvency and Bankruptcy (Application to Adjudicating Authority) Rules, 2016 on 24th November 2023 before the National Company Law Tribunal, Bengaluru seeking recovery of an alleged dues of INR 9,94,96,650/- with interest till March 31, 2023 together with short interest for the prior period and further interest till the actual date of payment from the Company.
- 2. The aforesaid alleged claim of Laburnum has already been disputed by the Company and is the subject matter of pending proceedings filed by the Company against Laburnum (the defendant) on 1st September, 2023, before the Additional City Civil and Sessions Court, Bangalore in Original
