ओलंपिक कार्याय पदक विजेता और भारत के शीर्ष पेशेवर मुक्केबाज विजेन्द्र सिंह ने जुल्फिकार मैमत अली के खिलाफ होने वाले मुकाबले से पूर्व चीन के इस मुक्केबाज पर तंज कसते हुए कहा कि वह इस मुकाबले को जल्द से जल्द जीतने की कोशिश करेगा क्योंकि चीन का माल अधिक दूर नहीं टिकता।

विजेन्द्र डब्ल्यूबीओ एशिया पैसिफिक सुपर मिडिलवेट चैंपियन हैं जबकि जुल्फिकार डब्ल्यूबीओ ओरिएंटल सुपर मिडिलवेट चैंपियन हैं और मुंबई के वली में एनएससीआई स्टेडियम में दोनों के बीच पांच अगस्त को होने वाले इस मुकाबले का विजेता अपना खिताब बचाने के अलावा प्रतिद्वंद्वी का खिताब भी अपने नाम करेगा। विजेन्द्र को आठ पेशेवर मुकाबलों का अनुभव है जिसमें से भारतीय मुक्केबाज ने आठों में जीत दर्ज की है जबकि मैमत अली ने नौ में से आठ मुकाबलों में जीत दर्ज की है। ये दोनों ही अपने देशों के नंबर एक मुक्केबाज हैं और दोनों ही पेशेवर सर्किट में अब तक अजेय हैं लेकिन विजेन्द्र को अपने प्रतिद्वंद्वी के 27 राउंड

के मुकाबले 30 राउंड का अनुभव है। विजेन्द्र ने इसके अलावा सात मुकाबले नाकआउट से जीत हैं जबकि मैमत अली के नाम छह नाकआउट दर्ज हैं।

मैमत अली के खिलाफ पांच अगस्त को होने वाले मुकाबले के संदर्भ में विजेन्द्र ने सोमवार को यहां एक कार्यक्रम के दौरान कहा, 'मेरी ट्रेनिंग काफी अच्छी चल रही है और मैंने अपने वजन को सीमित रखा है। पांच अगस्त को आप एक और नाकआउट की दुआ कीजिए। मैं इस मुकाबले को जल्द से जल्द निपटाने की कोशिश करूंगा। वैसे भी चाइनीज माल ज्यादा नहीं टिकता।' विजेन्द्र 31 बरस के हैं जबकि उनसे लगभग नौ साल छोटे हैं।

जब यह पूछा गया कि क्या चीन के मुक्केबाज को युवा होने के कारण तेजी का फायदा मिल सकता है तो विजेन्द्र ने कहा, 'मुझे नहीं लगता कि इससे कोई फर्क पड़ने वाला है। मुक्केबाजी अनुभव का खेल है और आपके मुक्कों में ताकत होनी चाहिए। गौरतलब है कि विजेन्द्र ने पिछले साल दिसंबर में फ्रांसिस चेका के खिलाफ अपने खिताब का सफल बचाव करने के बाद कोई मुकाबला नहीं लड़ा है लेकिन इस दिग्गज भारतीय ने कहा कि वह लगातार जिम और रिंग में ट्रेनिंग कर रहे हैं। विजेन्द्र ने कहा, 'जुल्फिकार के खिलाफ बाउट पहले अप्रैल में होनी थी लेकिन किसी कारण से वह इससे पीछे हट गया।
