## **NOTICE** **"Suspension of work"**

Inspite of our earlier notices of 10.03.2016, 12.03.2016, 14.03.2016 & 15.03.2016 and unstinted efforts of the management, the workmen have not been able to increase the production to standard/economical levels and / or bring down the hands per tons to agreed levels. The workers have failed to comply with the norms of productions as per agreement and as prevalent in the industry. The situation in the mills has continued to deteriorate, making working unviable

All are aware that at present whole jute industry has facing acute shortage of raw jute and prices are ruling at record levels. Hence, it was extremely important and urgent to reduce the cost of production by achieving high efficiency and lower hands/low as per agreement and reduce losses. However the workers are not willing to understand the gravity of the situation and continue with their indifferent working. Besides, due to scarcity adequate quantity of raw jute is also not available.

several appeals of the management to the workmen for eradication of all wasteful practices, stop loitering in the mill (leaving the places of work), stop resorting to concerted, illegal stoppage of work on one pretext or other in a reckless manner, maintain discipline and improve production have yielded no results.

Under the above circumstances the management has been left with no option but to impose "suspension of work" in the mill. Hence the "suspension of work" is declared with effect from 6 AM - 26<sup>th</sup> March'2016 in the mill. No wages /allowances will be paid during the period of "suspension of work" in the mill. The entry of the workmen during the period of continuation of "suspension of work" in the mill is strictly prohibited. The workmen deployed in essential services will only be allow to work according to requirement during the period of "suspension of work" in the mill.
