

Note: During the year in the financial statements the revenue of Acropetal Inc was included for the period April 2015 to Dec 2015, since Acropetal Inc ceased to be subsidiary w.e.f 4th January, 2016. So the assets and liabilities of Acropetal Inc as on 31st March 2016 have not been considered in the consolidated financials.

3. The figures of the previous period/year have been regrouped/re-arranged and/or recast wherever found necessary.
4. The consolidated Audited financial results are prepared in accordance with the principles and procedures for the presentation of the Consolidated Financial Statements as set out in the Accounting Standard 21 on Consolidated Financial Statements mandated by Rule 3 of the Companies (Accounting Standards) Rules 2006
5. The company has been passing through some financial difficulties, due to this -
 - i) The company borrowings outstanding to the tune of Rs. 9,795.13 lakhs have been classified as Non-Performance Assets by the financial institutions and have become payable in full.
 - ii) The company is facing difficulties in paying statutory dues to Service Tax & TDS departments.
 - iii) The company declared dividend in FY2011-12, out of the declared amount partial amount has been paid and the balance is still to be paid
- Inspite of all these, the company is generally paying salaries to the employees. The statutory dues are being paid in partial amounts and for the balance amounts the company has offered its properties for attachments to sell. The loan amounts with the lenders are sufficiently covered by the collateral securities provided to them. The company is working in parallel on various other options to close all the pending dues.
- iv) The company has accumulated losses and its networth has been drastically reduced and the company has incurred a net loss of Rs. 50.36 crores during the fourth quarter and Rs. 67.83 crores for the year ended 31.03.2016.

INDEPENDENT AUDITOR'S REPORT

TO THE MEMBERS OF ACROPETAL TECHNOLOGIES LIMITED

Report on the Standalone Financial Statements

We have audited the accompanying standalone financial statements of **ACROPETAL TECHNOLOGIES LIMITED** ('the Company') which comprise the Balance sheet as at 31st March 2016, the statement of profit and loss and the cash flow statement for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Standalone Financial Statements

The Company's Board of Directors is responsible for the matters stated in Section 134(5) of the Companies Act, 2013 ("the Act") with respect to the preparation and presentation of these standalone financial statements that give a true and fair view of the financial position, financial performance and cash flows of the Company in accordance with the accounting principles generally accepted in India, including the Accounting Standards specified under Section 133 of the Act, read with Rule 7 of the Companies (Accounts) Rules, 2014. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on these standalone financial statements based on our audit. We have taken into account the provisions of the Act, the accounting and auditing standards and matters which are required to be included in the audit report under the provisions of the Act and the Rules made thereunder.

We conducted our audit in accordance with the Standards on Auditing specified under Section 143(10) of the Act. Those Standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and the disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal financial control relevant to the Company's preparation of the financial statements that give a true and fair view in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on whether the Company has in place an adequate internal financial controls system over financial reporting and the operating effectiveness of such controls. An audit also includes evaluating the appropriateness of the accounting policies used and the reasonableness of the accounting estimates made by the Company's Directors, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our Qualified opinion on the standalone financial statements.

Basis for Qualified Opinion

1. The company has provided Interest on outstanding loans from banks/financial institutions upto 31/12/2015. However the company has reversed the entire interest of Rs. 9,11,46,915/- stating that they are in the process of one time settlement with the banks/financial institutions and likely to get substantial relief. Thus interest on the entire loans from such banks / institutions are not recognised as expenditure for the year 2015-16.
2. During the year the company received the Income Tax first appellate order for the Assessment year 2011-12 with substantial relief. As per the said order the income tax liability has come down from Rs. 10,44,80,750 to Rs.75,87,760.However the company has not recognised this as expenses.
3. The property at No.225-B,Bommasandra Industrial Area, Bommasandra Village, Attibele Hobli, Anekal Taluk, Bangalore-562107 having a book value of Rs.31,75,000 which was given as a collateral security to Axis bank, Corporate Banking Branch, Bangalore. Based on the examination of form 26AS there was a sale of property for Rs. 12,10,00,000/- and TDS of Rs. 12,10,000/-. This is not reflected in the accounts and shown as asset in the Balance sheet. We understand from the management that the market value of the property is much higher and the company is following up the bank, either to cancel the sale or give higher sale consideration as per prevailing market rate.

Opinion

In our opinion and to the best of our information and according to the explanations given to us, except for the effects of the matter described in the Basis for Qualified opinion paragraph, the aforesaid standalone financial statements give the information required by the Act in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at 31st March 2016, and its loss and its cash flows for the year ended on that date.

Emphasis of Matters:

We draw attention to the following matters in the Notes to financial statements:

1. The company is undergoing a problem in facing the going concern issue, here we mention events that may cast doubt about going concern assumption as follows (as per para 10 of SA 570 "Going Concern").
 - a. The company has borrowings of Rs. 97,95,13,759 /- which became repayable in full over one year before. The entity is already in breach of its agreed overdraft and the bank has refused to renew the borrowings. The entity has also been unsuccessful in applying to other financial institutions for re-financing. It is highly unlikely that the entity will be successful in renewing or re-financing the Rs. 97,95,13,759 /- borrowings.



- b. As referred in Note 7(i) to the Financial statements ,company is facing difficulties in paying statutory dues such as Service tax, TDS, Contribution to employees provident fund, Employees stake insurance, Central sales Tax, Dividend distribution Tax and Income Tax.

- c. Note 2(c) in the financial statements which indicates that the Company has accumulated losses and its Networth has been fully eroded, the company incurred a net loss during the current year (Rs.67.83 crores) and previous year (Rs.178.33 crores) and, the Company's current liabilities (Rs.155.97 crores) exceed its current assets (Rs.8.00 crores) as at the balance sheet date.
- d. As on May 1 2016, there were no employees on the rolls of the company and as company is managing with the assistance of consultants for maintaining accounts and allied activities.

These conditions indicate the existence of a material uncertainty that may cast significant doubt about the Company's ability to continue as a going concern. However, the financial statements of the Company have been prepared on a going concern basis.

b) Out of the Unsecured advances given to staff & ex-employees referred in Note 10(d) of the financial statements, there is uncertainty about recovery of Rs. 22,78,206/- as there is no recovery during the year and these are outstanding for more than a year.

c) The company has written off the Product development cost of 31,60,94,572/- during the year as impairment loss. We are not provided with any supporting documents, basis of evaluation of impairment. Hence we are unable to express an opinion on this matter.

Our opinion is not modified in respect of these matters.

Other Matters:

We did not audit the financial statements / information of Acropetal USA branch included in the standalone financial statements of the Company whose financial statements / financial information reflect total assets of Rs. 1,32,930/- as at 31st March, 2016 and there is no revenue for the year ended on that date, as considered in the standalone financial statements. The unaudited financial statements / information of this branch has been incorporated in the standalone financial statements.



Report on Other Legal and Regulatory Requirements

1. As required by the Companies (Auditor's Report) Order, 2016 ("the Order") issued by the Central Government of India in terms of sub-section (11) of section 143 of the Act, we give in the 'Annexure-A' a statement on the matters specified in the paragraph 3 and 4 of the Order.

2. As required by Section 143 (3) of the Act, we report that:

- (a) We have sought obtained all the information and explanations which to the best of our Knowledge and belief were necessary for the purposes of our audit;
- (b) Except for the effects of the matter described in the Basis for Qualified Opinion paragraph above, In our opinion, proper books of account as required by law have been kept by the Company so far as it appears from our examination of those books;
- (c) The Balance sheet, the Statement of Profit and Loss and the Cash flow statement dealt with by this Report are in agreement with the books of account;
- (d) Except for the matter described in the Basis for Qualified Opinion paragraph above, in our opinion, the aforesaid Standalone financial statements comply with the Accounting Standards specified under Section 133 of the Act excepting AS 11 and AS 29 with respect to Foreign exchange gains and disputed Income Tax Liability respectively, read with Rule 7 of the Companies (Accounts) Rules, 2014;
- (e) The going concern matter described in Para (1) under the Emphasis of Matters paragraph above may have an adverse effect on the functioning of the Company.
- (f) We have neither been given written representation from the directors nor secretarial audit report for the year that none of them are disqualified as on 31.03.2016 from being appointed as directors in terms of Sec 164(2). Form DD-B pursuant to sec 274(1)(g) of the Companies act,1956 has been filed on 27.10.2013, due to failure in payment of dividend since 27.10.2012.

However the company is of opinion that Sec 164(2) does not had to ipso facto vacation and it envisages vacation only at the end of the present tenure.

- (g) The qualification relating to the maintenance of accounts and other matters connected therewith are as stated in the Basis for Qualified Opinion paragraph above.
- (h) With respect to the adequacy of the internal financial controls over financial reporting of the Company and the operating effectiveness of such controls, refer to our separate report in "Annexure B"; and
- (g) With respect to the other matters to be included in the Auditor's Report in accordance with Rule 11 of the Companies (Audit and Auditors) Rules, 2014, in our opinion and to the best of our information and according to the explanations given to us:

i. The Company has disclosed the impact of pending litigations, except disputed Income tax liability on its financial position in its financial statements. – Refer Note 21 to the financial statements;




ii. The company did not have any long-term contracts including derivative contracts for which there were any material foreseeable losses.

iii. There has been no delay in transferring amounts, required to be transferred, to the Investor Education and Protection Fund by the Company.

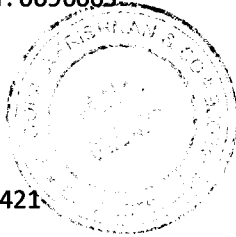

- (b) The assets have not been physically verified by the management during the year.

As per our examination of the documents, immovable properties of the company have been mortgaged to various banks for various loans. We have been provided with a copy of deeds, but no confirmation letter from the bank or institution was made available to us.
- ii) The Company is a service company, primarily rendering software services. Accordingly, it does not hold any physical inventories. Thus, paragraph 3(ii) of the Order is not applicable.
- iii) The Company has granted interest free loans to two body corporates covered in the register maintained under section 189 of the Companies Act, 2013 ('the Act'). The outstanding balances for the granted loans are as follows:





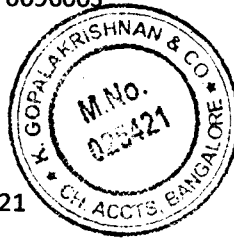

Because of the turnover in financial reporting personnel, we are unable to perform inquiries, observations, or other procedures to understand the flow of transactions and related controls in significant processes.

Disclaimer of Opinion

The system of internal financial controls over financial reporting with regard to the Company were not made available to us to enable us to determine if the Company has established adequate internal financial control over financial reporting and whether such internal financial controls were operating effectively as at March 31, 2016.

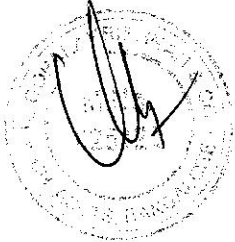


In the case of subsidiary companies and associate companies, none of the financials are audited and hence we are unable to express any opinion on this.

The consolidated financial statements also include the Group's share of net loss of Rs. 0.67 crores for the year ended 31st March, 2016, as considered in the consolidated financial statements, in respect of three subsidiaries and one associate, whose financial statements / financial information have not been audited by us. These financial statements / financial information are unaudited and have been furnished to us by the Management and our opinion on the consolidated financial statements, in so far as it relates to the amounts and disclosures included in respect of these subsidiaries and



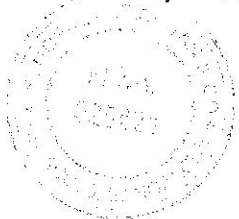
