# Labour unions step up protest over inflation

BMS says price rise tough to tame; CITU, AITUC to agitate on I-Day eve

New Delhi, 19 July

With the inflation rate hovering over 7 per cent for a third month in June, labour unions are stepping up efforts to take on the government on this issue.



Labour unions are looking to mobilise on some specific issues, but there are no immediate plans to call for a general strike

As part of these protests, the Centre of Indian Trade Unions (CITU), affiliated to the Communist Party of India (Marxist), is set to start a 'Samuhik Jagran' drive, beginning on August 1, which will conclude with an overnight dharna (sit in) at all district centres on the eve of the 75th Independence Day.

Umesh K N, national secretary, CITU, said: "There will be a national convention, jointly with All India Kisan Sabha and other agriculture workers' unions on September 5 at the Talkatora Stadium, in New Delhi, where our future programmes will be finalised."

Other labour unions, too, are planning to mobilise workers in the coming months.

The Indian National Trade Union Congress (INTUC) will consider a 14-point agenda, including inflation, unemployment, and minimum wages at its upcoming core committee meeting scheduled to be held next week.

"Inflation is rising through the roof and the government is least bothered to bring it under control. The INTUC will fight the government on the streets," said Ashok Singh, vice-president, INTUC, and governing body member, International Labour Organisation (ILO).

The All India Trade Union Congress (AITUC's) working committee at its two-day review meeting, which ended on Monday, decided to take up workers' issues by sectors (like banking, steel, cement, etc.). The AITUC, too, will start its mass awareness and mobilisation drive from August 1 and culminate on Independence Day.

Amarjeet Kaur, general secretary, AITUC, said: "We have prepared our resolution and will go to the prime minister as a central trade union to demand quashing of the labour codes. Now our battle has to be more volatile and militant," she added. "Wage repression and high inflation have made conditions worse for 90 per cent of the workforce engaged in the informal sector."

## BMS unconvincing

meeting in Bhubaneswar, scheduled to be held in the last week of August.

The BMS recently concluded its district-level deliberations to raise the issues of inflation, corporatisation of public sector undertakings (PSUs), wages, and social security.

Calling the government's efforts to curb inflation insincere and dishonest, BMS general secretary Binay Kumar Singh said: "The economic condition is very bad and the rise in inflation is becoming difficult to tame. The government has also failed to bring petrol and diesel under the ambit of the goods and services tax (GST)."

The BMS will start a 'Jan Jagran' mobilisation drive to create awareness on corporatisation of PSUs, minimum wages, and social security issues. It will organise a national level protest in New Delhi on November 17 to address these issues.

## General strike

Though labour unions are looking to mobilise on some specific issues, there are no immediate plans to call for a general strike. However, union leaders say such nationwide protests could take place if the government does not act fast. "National-level general strikes are not a day-to-day affair. But, more such protests will be witnessed in the coming days," said Tapan Kumar Sen, general secretary, CITU.

On the question of trade unions joining hands, AITUC's Kaur said central trade union organisations (CTUOs) will meet over the week to discuss the matter.

Finance Minister Nirmala Sitharaman recently noted that Centre is watchful of the price situation and had already taken necessary steps to bring inflation under control by reducing excise duty on petrol and diesel, banning wheat exports, allowing duty free import of certain crude edible oil and revising duty structure on steel and steel products. "Will continue the pointed attack on inflation," she said.

But the government's efforts to tackle rising prices appear not to have convinced the Bharatiya Janata Party's (BJP's) sister organisation, the Bharatiya Mazdoor Sangh (BMS). The union is set to discuss a plan of action at its central

# Oppn stalls proceedings over 'unparliamentary' GST hike

New Delhi, 19 July

The entire Opposition united on Tuesday to force both the Lok Sabha (LS) and the Rajya Sabha (RS) to adjourn on the issue of price rise and the imposition of the goods and services tax (GST) on packaged food like milk and yoghurt.

The issue of the new military recruitment scheme Agnipath was also flagged, even as Opposition candidate for Vice-President Margaret Alva filed her papers. No leader from the Trinamool Congress or the Aam Aadmi Party was present during the nomination filing of the joint Opposition candidate.

The House adjournments followed protests, led by Congress leader Rahul Gandhi and Opposition Members of Parliament (MPs), including Supriya Sule of the Nationalist Congress Party, Ram Gopal Yadav of the Samajwadi Party, and Priyanka Chaturvedi of the Shiv Sena. Standing before the Mahatma Gandhi statue outside Parliament, Opposition leaders demanded roll-back in the prices of liquefied petroleum gas. They also held banners and placards which read: 'High inflation, continuous price rise badly affecting common citizens. How will they survive?'

Congress MPs from both the Houses took part in the protest. They included the Leader of Opposition in RS Mallikarjun Kharge and the Leader of Congress in LS Adhir Ranjan Chowdhury. "The imposition of 5 per cent GST on curd, paneer, and other commodities of daily use will hurt the common man. We will protest inside the House as well," said Kharge.

Congress Whip in LS, Manickam Tagore, said Opposition members led by his party wanted a discussion on price rise and GST, but the government did not allow it and the Speaker adjourned the House till 2 pm. The House was later adjourned for the day. The



## FM: Supply-side steps taken to cool inflation

Prices of major essential commodities are monitored by the government on a regular basis and corrective action is taken from time to time, said Union Finance Minister Nirmala Sitharaman in a written reply to the Rajya Sabha. The measures included cut in import duties and cess on pulses, rationalisation of tariffs, and imposition of stock limits on edible oils and oil seeds.

## 392,000 Indians gave up citizenship in last 3 years

More than 392,000 Indians gave up their citizenship in the past three years and 170,000 of them, the highest, took up American citizenship. Lok Sabha was informed on Tuesday. Union Minister of State for Home Nityanand Rai said that according to details provided by the Ministry of External Affairs, individuals renounced Indian citizenship for reasons personal to them and took citizenship in over 120 countries. A total of 3,92,643 Indians gave up their citizenship in 2019, 2020 and 2021, he said in a written reply to a question.

## Inclination towards radical ideologies minuscule: Govt

Radicalisation by terror groups like ISIS and Al Qaeda is a major problem faced by countries, and some foreign agencies have been making efforts to radicalise people in India, Union Minister Nityanand Rai said on Tuesday. However, inclination towards radical ideologies in India is minuscule as compared to the population of the country, he said.

## 1,000 complaints against Air India in 3 months

Around 1,000 passenger complaints have been received against Air India during the past three months related to various issues, including refund of fares, overbooking of flights, and staff behaviour, Minister of State for Civil Aviation VK Singh said on Monday. The Tata group in January took control of Air India after winning the bid

last year. Aviation regulator DGCA last month imposed a fine of ₹1 million on it for denying boarding for valid tickets and not providing compensation.

protest also came after the RS secretariat issued a circular saying no protest or demonstration would be allowed inside the Parliament complex.

"The rupee has touched ₹80. Gas cylinder delivery agent asking for ₹1,000. 13 million unemployed people in June. GST burden on food-grain. No one can stop us from raising public issues. The government will have to answer. Running away from discussion and questions in Parliament is most 'unparliamentary', Mr Prime Minister," he tweeted in Hindi.

Congress leader also dubbed the government as 'extortionist' and said, "No matter how much the Prime Minister (PM) tries to silence us by terming many words as 'unparliamentary', he will have to answer".

Gandhi said when the PM was in the Opposition, he had made inflation the biggest issue, but today he has pushed the public into a 'deep quagmire of problems, in which people are getting drowned every day'.

Congress Spokesman Shaktisinh Gohil said the items on which GST had been hiked included solar water heaters, packaged wheat, buttermilk, paneer, etc on which tax was raised 'extortionately'.

As the Supreme Court referred the issue of all public interest litigations on the new military recruitment scheme Agnipath to the Delhi High Court, Gohil said the country must take cognisance of the fact that military recruitment henceforth will be done for a job that will have a three and a half year tenure on contract, with six months of training, no pension, no health facilities, and no prospect of promotion. This was nothing but exploitation.
