Pursuant to the merger of a Promoter Group Company i.e. ANM Enginnering & Works Private Limited with MNV, MNV has now become a Promoter and hence, its holding has been clubbed with the other Promoters who are now its PACs.

³ Note: ANM Enginnering & Works Pvt Ltd ("ANM"), the erstwhile promoter which was holding the aforesaid shares, has been dissolved without winding up in terms of the above Scheme and Order with effect of 22 June 2015.
