Sub: Proceedings of the 22nd Annual General Meeting of Rodium Realty Limited held on Saturday, September 26, 2015.

The 22nd Annual General Meeting ("AGM") was held on Saturday, September 26, 2015 at 9.00 a.m. at Ground Floor, X'trium Bldg., C.T.S. No.291, Andheri – Kurla Road, Near Holy Family Church, Andheri (East), Mumbai – 400069.

The meeting was chaired by Mr. Deepak Chheda, Chairman and Managing Director of the Company. There were total of 51 members present in the meeting out of which 30 members were present in person representing 2,332,527 Equity Shares and 21 members were present as Proxy representing for 263,200 Equity Shares of the Company.

Ms. Devanshi Shah, Company Secretary of the Company verified the quorum and declared the Meeting to be in order with the permission of the Chairman. Further members were informed that the Statutory Registers, Attendance Register, Proxy Register were available for inspection during the period of the Meeting.

Chairman commenced the meeting with Chairman's Speech giving brief on the financial performance of the Company during the Financial Year 2014-15 and future outlook of the Company. Chairman also gave a brief outlook over the industry, based on the current scenario and various hindrances in the real estate sector likely to have impact during the forthcoming years.

On invitation by the Chairman, several members provided their queries, suggestions and views. Chairman addressed the queries satisfactorily and considered the suggestions from the members for improvement.

Company Secretary informed the members that pursuant to the requirements of Section 108, of Companies Act, 2013 read with Rule 20 of Companies (Management & Administration) Rules, 2014 and Clause 35B of Listing Agreement the Company had provided e-voting facility to the Equity Shareholders of the Company from September 23, 2015 to September 25, 2015, on the business to be transacted at the 22nd AGM. Thereafter, Chairman invited the members for discussion on the business to be transacted at the meeting. The Chairman further informed the members that since no voting was done, the final results will be available on Company Website and BSE website.

The Scrutinizer had submitted his Report dated September 28, 2015 on the Result of the Remote e-voting concluded on September 25, 2015 and Ballot papers received. According to the report, all the Resolutions had received requisite majority.
