 - 1.1 The Company completed the dispatch of Notice of Postal Ballot dated 15th May, 2015 along with Postal Ballot Form and self-addressed business reply envelope to its members, whose names appeared in the Register of Members as on 15th May, 2015.

- 1.2 The e-voting period commenced on Monday, 25th May, 2015 (10.00 a.m.) and ended on Tuesday, 23rd June, 2015 (05.00 p.m.).
- 1.3 Particulars of all the Postal Ballot Forms received from the members have been entered in a register separately maintained for the purpose.
- 1.4 All Postal Ballot Forms received upto the close of working hours of 23rd June, 2015, being the last date and time fixed by the Company for receipt of the forms, are considered for my scrutiny.
- 1.5 The Postal Ballot Forms were duly opened on 24th June, 2015 in my presence and scrutinized. The shareholding was matched / confirmed with the Register of Members of the Company / list of beneficiaries as on 15th May, 2015.
- 1.6 The data for e-voting was downloaded on 24th June, 2015 (11.30 a.m.) after the e-voting module was disabled by the National Securities Depository Limited (NSDL) Limited.
- 1.7 The e-voting data was scrutinized for verification of votes cast in favour and against the resolution.
- 1.8 The Company did not receive any envelope containing Postal Ballot form after 23rd June, 2015.
- 1.9 702 envelopes were returned undelivered containing Postal Ballot Form.
