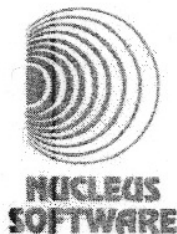

- **Technology or Implementation Excellence.** Some initiatives are noteworthy for their extreme difficulty, complexity of technology, or implementation excellence. Celent recognizes initiatives that stand apart in this area

Celent usually receives a number of nominations that score highly in Technology or Implementation Excellence, although perhaps not highly enough across all categories to win an award for the financial institution. Typically, such initiatives involve a technology vendor.

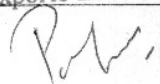

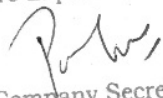
