HISTORY OF PRESENT ILLNESS : PATINT WAS APPARENTLY ALRIGHT ONE DAY BEFORE ADMISSION WHEN HE STARTED WITH ABOVE MENTIONED COMPLAINTS. HE CAME TO EMERGENCY ROOM AND STARTED COMPLAINING OF BREATHLESNESS AND WAS ADMITTED FOR FURTHER MANAGEMENT. IN WARDS HE HAD AN EPISODE OF HYPOTENSION, HYPOGLYCEMIA, AND DESATURATION THEREFORE WAS SHIFTED TO MICU FOR FURTHER MANAGEMENT. HE WAS MANAGED OVERNIGHT ON NIV AND WAS STARTED OF NOR-ADRENALINE IN VIEW OF HYPOTENSION. ON 28/11/17 AT AROUND 9:00PM PATINET WENT INTO HYPOGLYCEMIA, CORRECTION GIVEN. AT AROUND 9:30 PM HE WAS IN RESPIRATORY DISTRESS WITH TACHYPONEA AND TACHYCARDIA ABH S/O RESPIRATORY ACIDOSIS WITH HYPERCAPNEA. RELATIVES WERE COUNSELLED REGARDING THE NEED OF INTUBATION AND MECHANICAL VENTILATION BUT DEFERRED, THEREFORE DNR STATUS WAS TAKENA ND SUPPORTIVE TREATMENT CONTINUED. ON 29/11/2017 AT AROUND 2:'00PM PATINET HAD AN EPIOSODE OF BRADYCARDIA, INJECTION ATROPINE GIVEN, CPR STARTED AND CONTINUED. PATINET COULD NOT BE REVIVED AND DECATH DELARED TO RELATIVES AT AROUND 2:54 PM.
