I, Vinay B L, Company Secretary in Practice, have been appointed as Scrutinizer by the Board of Directors of WeP Solutions Limited for the purpose of scrutinizing evoting process (remote e-voting) in a fair and transparent manner and ascertaining the requisite majority on postal ballot resolution through remote e- voting carried out pursuant to the provisions of Section 110 and 108 of the Companies Act, 2013 ("the Act") read with Rule 22 and Rule 20 of the Companies (Management and Administration) Rules, 2014 ("the Rules") as amended from time to time, read with the Notice for Postal Ballot through remote e- voting dated 16th September, 2022 ("the Notice") for the Equity Shareholders of the Company, hereby submit my report as under:

- 1. The compliance with the provisions of the (i) Companies Act, 2013 and the Rules made thereunder (ii) the MCA Circulars (iii) the SEBI (Listing and Disclosure Requirements) Regulations 2015 relating to voting through electronic means (by remote e-voting) by the shareholders on the resolutions proposed in the postal ballot notice of the Company is the responsibility of the management. The management of the company is responsible for ensuring a secured framework and robustness of the electronic voting systems.
- 2. As a scrutinizer for the e voting process my responsibility is to ensure that the voting process is conducted in a fair and transparent manner and renders

Scrutinizer's Report of the total votes cast "in favour" or "against" if any, to the Chairman on the resolutions.

- 3. The remote e-voting facility was provided by National Securities Depository Limited (NSDL).
- 4. It was informed to me that the Postal ballot Notice dated 16th September 2022 was sent to the Shareholders in respect of the Resolutions indicated in point No. 9 on 28th September 2022 electronically.
- 5. As stated in the notice of the Postal ballot sent to the shareholders and the 'Advertisement' published pursuant to Rule 22(3) of the Companies (Management and Administration) Rules, 2014 (Amendment Rules 2015) on 29th September 2022 the remote e-voting opened at on Thursday, 29th September 2022 at 9.00 A.M and ended on Friday, 28th October 2022 at 5.00 P.M (Both Inclusive). NSDL E-voting platform was blocked thereafter.
- 6. The Shareholders holding shares as on Friday, 23rd September 2022, "cutoff date", were entitled to vote on the resolutions stated in the Notice of the Postal ballot.
- 7. The particulars of postal ballot received from members in electronic voting report generated from NSDL have been entered in a separate Register maintained for the purpose.
- 8. After closure of e-voting, the votes cast through remote e-voting were unblocked and downloaded from the e-voting website of National Securities Depository Limited (https://www.evoting.nsdl.com) in the presence of two witnesses, who are not in the employment of the company. The e-voting data/results downloaded from the e-voting system of NSDL were scrutinized and reviewed, the votes were counted, and the results were prepared.
