Sub: Calling Off strike w.e.f. 29.08.2017: reg.

Sir,

With reference to strike called by our Union on 20.07.2017 owing to Non-payment of salary for the month of May'17 & Jun'17 and other long pending dues, various meeting were called by the officials of Andaman & Nicobar Administration, but Management has not come for settlement of our demands till date.

However, today on 29.08.17, the Union is hereby Calling-Off the strike in the larger interest of the people of South Andaman and keeping in view the upcoming festival namely UID, Onam, Durga Puja etc.

That strike called off in the presence of Comm-cum-Secretary (Power), S.E. Elect.Dept., Union Patron – Mr. Vishal Jolly and management representative Mr. Biji George.

That, it has been come to our knowledge that A & N Administration mainly Chief Secretary, Comm-cum-Secretary (Power), Secretary (Law), Secretary (Labour), Secretary (Finance), Deputy Commissioner (SA) and best efforts of the Hon'ble Lt. Governor – Prof. Jagdish Mukhi, an Order No. 1031, dtd. 10.08.17 was issued by A & N Admn. wherein an amount of Rs.12 lakhs (by recovering the said amount from M/s SPCL alongwith interest at the time of settlement of expiry of PPA) monthly is to be disbursed to the operational staff of M/s SPCL under the supervision of Labour Commissioner to get the Plant operational.



That, we are again requesting you to immediately come forward for settlement of our above said issues as soon as possible for better Employer-Employee relationship and for smooth running of the Plant.


