# Aviva Wins Celent Model Insurer Award for Data and Analytics Transformation by TCS

With the new architecture, data engineering pipelines are built mostly on cloud-native or open-source technologies, allowing faster and consistent data delivery. The marquee features of the solution include a scalable and serverless architecture capable of real time streaming, big data processing, custom built engineering pipelines, technology agnostic audit and reconciliation frameworks and integration with data exploitation capabilities for advanced machine learning.

This modernisation initiative has delivered significant business value including reduction in data acquisition times by ~80% for business users and reduction in net new data ingestion delivery timelines by ~60%. It has also enabled commercial business teams to change business rules ~50% faster and improved the underwriting and pricing teams' workflow from days to hours, enabling them to offer more accurate policy pricing to customers. Aviva's business teams have been empowered with amplified capabilities in areas such as fraud detection, investment management and connected car/home ecosystem propositions.

"The One Lake and Platform Modernisation programme has brought Aviva a step closer to becoming a data and insights led insurance organisation. Our team worked closely with TCS and leveraged their contextual knowledge, cloud and data capabilities to drive this transformation," said David Young, Director, Data, Analytics & Group Platforms, Aviva.
