Alibaba eyes brick-and-mortar department store space

After conquering grocery stores, Alibaba.com is setting its sights on a new part of China's \$4-trillion retail sector: Department stores.

The e-commerce giant, which is also venturing into retail management and operations, is increasingly looking at traditional brick-and-mortar businesses. Chairman Jack Ma, Vice Chairman Joseph Tsai and Chief Executive Officer Daniel Zhang said in interviews with Bloomberg News on the company's 10th anniversary. Alibaba started in Ma's apartment in 1999, is worth \$45 billion today.

The e-commerce, spending less than a month now, Alibaba.com closed for \$1.7 billion acquisition of Whole Foods Market, disrupted Alibaba's strategy for dealing with competitors, its vision on retail and challenges the company will face. Ma said Alibaba will need to embrace a different retail form, an e-commerce site, and move away from its best-in-class approach to give a larger share of profit.
