I, Dhrumil Mahendra Shah of M/s Dhrumil M Shah & Co., Practising Company Secretaries, had been appointed as the Scrutinizer by the Board of Directors of PENINSULA LAND LIMITED, pursuant to Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20, 21(2) & 22 of the Companies (Management and Administration) Rules, 2014, to conduct the remote e-voting process and to scrutinize the physical ballot forms received from the shareholders in respect of the below mentioned resolutions passed at the Annual General Meeting of PENINSULA LAND LIMITED held on Friday, the 28th August, 2015 at 03:00 p.m.

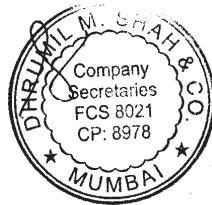


