In compliance with Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015, it is to inform that following Power Purchase Agreement (PPAs)/Bulk Power Supply Agreement (BPSAs) has been extended/executed with beneficiaries for the period of 35 years from the date of commercial operation (COD) of respective project/power station in recent past:

- PDD, Govt. of J&K has extended PPA/BPSA for the period of 35 years from the date of commercial operarion of SEWA-II, Salal, Uri-I, Tanakpur, Chamera-I, Dulhasti and Chamera-II Power stations on the same terms and conditions as envisaged in the existing.
- PPA in respect of Kishanganga HE project has been signed with "Chhattisgarh State Power Distribution Company Ltd" (CSPDCL) for the period of 35 years from date of COD of the project for 100 MW.
- PPA in respect of Tawang-I and Tawang-II HE project has been signed with "Uttarakhand Power Corporation Ltd" (UPCL) for the period of 35 years from date of COD of the project.
- HPSEB Ltd has extended PPA/BPSA for the period of 35 years from the date of COD of Salal, Uri-I, Tanakpur, Chamera-I, Chamera-II, Chamera-III, Dhauliganga and Parbarti-III power stations on the same terms and conditions as laid down in existing agreement.
- PPA in respect of Rangit and Teesta-V power stations have been extended for the period of 35 years from date of COD of last unit of respective power stations on the same terms and conditions as laid down in the original signed PPAs with "Jharkhand Bijli Vitran Nigam Ltd".
