There been appointed as a Scrutinizer vide Resolution passed by the Board of Directors of Mukta α m. Himited ("The Company") on 6^{19} October, 2015 for conducting the Postal Ballot process in connection with the above referred matter.

I submit my report as under:

- 2.1 The Company completed the despatch of Notice of Postal Ballot along with the Postal Ballot Forms and self—addressed stamped envelopes through Courier on 16th October, 2015 through M/s. Western Press Private Limited to the Members, whose names appeared on the Register of Members/List of Beneficiaries as on 9th October, 2015.
- 2.2 The Sealed Postal Ballot Forms received from the members were kept under the safe custody of the Registrar and Share Transfer Agent i.e. M/s. Link Intime India Private Limited at C 13, Pannalal Silk Mills Compound, L.B.S. Marg, Bhandup (West), Mumbai 400 078.
- All Postal Ballot Forms, received up to the close of working hours (1700 hours) on 16 November, 2015, the last date and time fixed by the Company for receipt of the Postal Ballot Forms were considered for my scrutiny.
- 2.4 Envelopes containing Postal Ballot Forms received after 1700 hours on 16th November, 2015 were not considered for my scrutiny. These envelopes were not opened.
- 2.5. The Postal Ballot envelopes were opened on 17th November, 2015 in the presence of my authorized representative.
- 2.6 Particulars of all the Postal Ballot Forms received from the members and the votes cast by electronic mode have been entered in a Register separately maintained for the purpose in electronic mode.
- 2.7 Envelopes containing Postal Ballot Forms which were returned undelivered were also not opened.
- 2.8 I have not found any defaced/mutilated Postal Ballot Form.
