(#) 1,01,013 (0.20%) equity share of Orchid Pharma Limited ('Company') were pledged with SBICAP Trustee Company Limited. On 19.12.2023, the pledge was invoked and 85,167 (i.e.0.17%) Equity Shares out of 1,01,013 total pledged equity shares were transferred to our Demat Account. The necessary disclosure was made under regulation 29(2) for invocation of abovementioned equity shares of the company to stock exchanges on 20.12.2023. Further, a sale of 69,782 shares were sold in the open market on 22.12.2023 and the disclosure was made under regulation 29(2) for sale of the said equity shares of the company to stock exchanges on 22.12.2023. Now as disclosed above 15,385 equity shares of the company were sold in open market and hence this disclosure is being made as under SEBI (Substantial Acquisition of Shares and Takeover) Regulation, 2011.
