Mahesh Shah habitual bragger, 'shows off' wealth through

AHMEDABAD-BASED real estate dealer Mahesh Champaklal Shah, who had voluntarily declared Rs 13,860 crore under the Income Declaration Scheme (IDS), was interrogated for several hours on Saturday night. After the interrogation, he was taken home, dressed in a police uniform, to conceal his identity for security reasons.

Shah, who was interrogated in the presence of a doctor and police personnel by five to six Income Tax officials, revealed the

However, we have not come across any evidence suggesting that he actually was involved in such big dealings," a top Income Tax official said.
