In terms of requirements of the Act, and the relevant Rules, Company has fixed Saturday, September 16, 2017 as the 'Cut-off Date'. The remote e-voting / voting rights of the shareholders/ beneficial owners shall be reckoned on the equity shares held by them as on the Cut-off Date i.e. September 16, 2017 only.

Item No. 4

Mr. Balbir Singh Uppal is a Promoter and Managing Director of the Company. Board in its meeting held on 12th August, 2017 has, subject to the approval of members, approved the re-appointment of Mr. Balbir Singh Uppal, as Managing Director for a further period of 3 years w.e.f 1st September 2017. The aforesaid reappointment shall be subject to the approval of the members.

The Board in its meeting held on 12th August, 2017, on the recommendation of the Nomination and Remuneration Committee, approved the remuneration (as set out in the resolution) payable to Mr. Balbir Singh Uppal.

Mr. Balbir Singh Uppal satisfy all the conditions set out in Part-I of Schedule V to the Act as also conditions set out under subsection (3) of Section 196 of the Act for being eligible for his re-appointment. He is not disqualified from being appointed as Directors in terms of Section 164 of the Act.

The above may be treated as a written memorandum setting out the terms of re-appointment of Mr. Balbir Singh Uppal under Section 190 of the Act.


