

Implementation of the Prevention of Money-laundering (Maintenance of Records) S Amendment Rules, 2017 with respect to seeding of Aadhaar number

Investors are requested to note that the Ministry of Finance (Department of Revenue) in consultation with the Reserve Bank of India has made certain amendments to the Prevention of Money-laundering (Maintenance of Records) Rules, 2005, namely, the Prevention of Money-laundering (Maintenance of Records) Second Amendment Rules, 2017. These Rules have come into force with effect from June 1, 2017. These Rules, *inter alia*, make it mandatory for investors to submit Aadhaar issued by the Unique Identification Authority of India (UIDAI) in respect of their investments.

Accordingly, investors are requested to note the following requirements in relation to seeding of Aadhaar number and other prescribed details to the Fund/its Registrar and Transfer
