a) A detailed explanation regarding the rationale of the Scheme.

b) That whether a copy of the Scheme along with the Valuation Report was submitted to all the regulatory authorities and that no comments have been received from any regulatory authority regarding the valuation report and exchange ratio.

c) Whether objections have been received for the proposed Scheme from any person interested.

d) Whether the No Objection Certificate from the Income Tax Department is obtained?

Pursuant to the said directions dated 05<sup>th</sup> day of June, 2017, seeking clarifications, the Petitioner Companies submitted all the above details by virtue of an affidavit dated 27.06.2016 with the Hon'ble Tribunal.
