The APTEL order now paves the way for Sasan Power Limited to recover the unpaid amount of nearly Rs. 850 crores from the procurers. Sasan Power would also be entitled to nearly Rs. 200 crore of carrying cost as per the PPA.

The Sasan Ultra Mega Power Project implemented in Singrauli District of Madhya Pradesh, is the largest integrated power plant cum coal mining project at a single location in the world, involving investment of over Rs. 27,000 crore.
