Sub: **Grant of Stock Options under the Associate Stock Option Plan (ASOP 2015)**

This has reference to our letter Ref:PCSL/SEC/2014-15 dt.30/04/2015 regarding intimation of grant of stock Options by the Nomination and Remuneration & Compensation Committee of the Company at its meeting held on April 30, 2015.

There was a typographical error in the market price as on 29<sup>th</sup> April 2015 taken for calculation of Grant Price. Please read the market price as mentioned in our aforementioned letter as Rs.153.20 instead of Rs.153.

Accordingly the Grant Price has been arrived on the following basis :

**The Grant Price has been arrived on the following basis :**

As per the Swarnam 101 category of the ASOP 2015 scheme, the Grant Price per Option shall be discount on Market Price as given below:

If the Market Price is between Rs.126 to Rs.360/-, discount of 15% is to be applied on the Market Price prevailing on the previous day to the Grant Date.

Accordingly, 15% discount is applied on the Market Price of Rs.153.20 as on 29<sup>th</sup> April 2015 (NSE) and the Discounted Market Price arrived is Rs.130.22/- which is higher than the floor price of Rs.126.

Hence Grant Price for 439,000 Stock Options granted by the Committee is Rs.130.22.

**The vesting schedule from the date of grant is as follows:**

From the Date of Grant	Swarnam 101
At the end of Year 1	10%
At the end of Year 2	15%
At the end of Year 3	20%
At the end of Year 4	25%
At the end of Year 5	30%

On the expiry of the vesting period, the associates have the right to convert the options into Shares either in full or in tranches at any time during the exercise period as provided under the Scheme.
