Pursuant to Regulation 7 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we have been informed the following, by Integrated Enterprises (India) Limited (IEIL) [former name], the Registrar and Transfer Agent (RTA):-

- i. As a part of their business restructuring, the RTA had filed the scheme of De-merger, for demerging its Registry undertaking into a separate Company, "Integrated Registry Management Services Private Limited", a Private Limited Company owned and controlled by the Promoter Group of IEIL and managed by the senior management of IEIL. The said scheme has been approved by the High Court, Madras during June 2016.
- ii. Consequent to the above approval, an application in this regard was filed with the SEBI by our RTA, seeking approval for changing its name from 'Integrated Enterprises (India) Limited' to "Integrated Registry Management Services Private Limited". The above mentioned application has been approved by the SEBI vide its Certificate of Registration dated February 17, 2017 (copy enclosed).

We have also been informed by our RTA, that pursuant to the demerger scheme approved by the High Court, Madras, there will not be any change in control / ownership / management / operational team, except for the change in name of the Company.

We further wish to inform you that the new name of our RTA also bears the same SEBI Registration Number: INR000000544.
