Results overview - Quarter ended June 30, 2015 v/s June 30, 2014:

The Company has registered strong growth in financial performance in the Q1 of FY 2015-16.

Sales rose by **45%** to **Rs.247.36 crore** from Rs.170.86 crore reported in the corresponding three months ended in the previous year.

Operating Profit (EBITDA) grew by **67%** to **Rs.36.67 crore** from Rs.21.94 crore reported in the corresponding three months ended in the previous year.

Profit Before Tax (PBT) increased by **93%** to **Rs.30.04 crore** from Rs.15.59 crore reported in the corresponding three months ended in the previous year.

Profit After Tax (PAT) climbed by **95%** to **Rs.23.98 crore** from Rs.12.32 crore reported in the corresponding three months ended in the previous year.

Earnings Per Share (EPS) (Basic) for the quarter is **Re.0.93** (Face Value of Share: Re.1)

The current order book is **Rs.530.88 crore**.
