## Code of Practices and Procedures for Fair Disclosure of Unpublished Price Sensitive Information

This Code of Practices and Procedures for Fair Disclosure of Unpublished Price Sensitive Information ("Code") is adopted by Action Construction Equipment Limited ("The Company"). This Code is in compliance with Regulation 8(1) of the Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations, 2015 ("Regulations") read with Schedule A of the Regulations, details as under:-

1. The Company shall make prompt public disclosure of unpublished price sensitive information that may impact price discovery no sooner than credible and concrete information comes into being in order to make such information generally available.
2. The Compliance Officer so designated by the Board under the Regulation serve as Chief Investor Relations Officer to deal with dissemination of information and disclosure of unpublished price sensitive information.
3. The Chief Investor Relations Officer shall make prompt dissemination of unpublished price sensitive information that gets disclosed selectively, inadvertently or otherwise to make such information generally available.
4. The Company shall provide appropriate and fair response to the queries on news reports and requests for verification of market rumors by the regulatory authorities.
5. The Company shall ensure that information shared with analysts and research personnel is not unpublished price sensitive information.
6. The Company shall publish proceedings of meetings with analysts and other investor relations conferences on the official website to ensure official confirmation and documentation of disclosures made.
7. All unpublished price sensitive information within the Company shall be handled on a need-to-know basis.

### AMENDEMENT /REVIEW

The Board of Directors of the Company may amend, abrogate, modify or revise any or all clauses of this Code in accordance with the applicable provisions of the Regulations, listing agreement entered into by the Company with the stock exchanges and guidance note issued by such stock exchanges, from time to time.
