Finally, a preferential issue of Equity Shares of face value of Rs. 10 each which could include convertible warrants of an amount up to Rs. 350 Crores to Manav Investment and Trading Company Limited, a promoter group company, was approved. The Preferential Issue will follow the process prescribed in Chapter VII and other applicable Chapters of the SEBI (Issue of Capital and Disclosure Requirements), Regulations, 2009 as well as other regulatory provisions, to

the extent applicable and relevant Shareholder approvals will be obtained through Postal Ballot.

2. Reiterated that the Company going forward would further enhance the robustness of its Tyre Business. This could include a possible induction of a partner in the Business with specific expertise in the radial segment so as to complement the Company's ongoing efforts.

A Board Committee has been empowered to decide and action on the detailed modalities for both (1) and (2) above.
