Jan CPI Inflation Hits 7-mth High

New Delhi: India's retail inflation accelerated to a seven-month high of 6.01% in January, breaching the upper limit of the Reserve Bank of India's 2-6% target rate for the first time after June 2021.

Wholesale inflation eased marginally during the month but remained in double digits. RBI Governor Shaktikanta Das played down inflation concerns, saying the uptick in retail inflation in January was primarily due to statistical reasons.

The retail inflation rate based on the Consumer Price Index (CPI) jumped to 6.01% in January from 5.66% in the trailing month and 4.06% in January last year, data released by the National Statistical Office showed.

food was a key inflation driver. Experts said the price rise is not likely to change the central bank's outlook on interest rates immediately. The RBI had last week left policy rates unchanged, projecting a lower 4.5% consumer inflation in FY22.

A surge in rural inflation to 6.1% in January from 5.4% in the previous month lifted the overall inflation while urban inflation remained unchanged at 5.9%.

The Volatility Index (VIX) surged 23% to 22.98, suggesting traders see higher risks to the market in the near term. Monday's high of 17,100 will now be seen as immediate resistance and until the Nifty reclaims this level, selling pressure could be seen on intraday pull-backs.

Russia on one of the biggest oil producers and any supply disruption could result in prices shooting up further. For India, elevated oil prices is bad news as it imports over 80% of the country's crude requirements.

Until the time the global uncertainty continues, market volatility is expected to remain on the higher side, said Siddhartha Khemka, Head - Retail Research, Motilal Oswal Financial Services. Traders are advised to avoid leverage and stay light on their positions.

Rising oil prices could add to inflationary pressures that several economies across the globe are facing. In the US, January consumer inflation had the highest increase since 1982, intensifying concerns that the Fed might be forced to act sooner and faster.

Considering the current market fall and less time available for the IPO was said to be the reason for the government to launch roadshows, the source said. The government is aiming to raise up to \$10 billion (about \$75,000 crore) through the LIC IPO, which is also seen as crucial to New Delhi's investment target to meet fiscal deficit goals for FY22.

The government will sell 5% in the public issue and around 316 million shares will be on offer, according to the offer document filed with the market regulator. LIC on Sunday filed the draft prospectus with the capital market regulator for its much-awaited public issue. Ten banks, including JP Morgan, Goldman Sachs, Bank of America Securities, SBI Capital Markets, Kotak Mahindra, Citigroup, Axis Bank, Nomura, ICICI Securities and JM Financial, are managing the share sale.
